Reporting to the Senior Manager, Climate Change and Asset Management this position will lead the implementation of the Town's Corporate Asset Management (CAM) program to meet the Ont. Reg. 588/17 requirements. The scope of work includes developing and implementing asset management policies, strategies, decision frameworks, processes and tools in alignment with the Town's long terms goals and vision. The position will also collaborate with internal teams and manage consulting services to complete various types of projects.

Accountabilities:

- Develop decision frameworks, business processes and tools that incorporate capital and operating budget development, prioritization, risk analysis, levels of service and life cycle costing
- Lead the development, implementation and review of strategic and departmental asset management plans in collaboration with the asset management network team
- Complete various projects including condition assessments, lifecycle analysis and forecasts, operations and maintenance practices development, capability and gap assessments, capital and operating budget forecasting and to roll out an asset management software solution
- Document current asset management processes, including gathering information and input from stakeholders
- Support the implementation of asset management software solution and data management strategies
- Prepare and present analysis related to asset management planning and capital budgeting to internal stakeholders
- Maintain the Town's main asset inventories and databases to support asset management planning
- Conduct detailed analysis and forecasting on infrastructure deterioration, risk, and levels of service while integrating climate change impacts
- Conduct financial analysis that includes, but is not limited to development of replacement and intervention costs, short and long range reinvestment forecasts, lifecycle analysis, and economic analysis
- Support the development of a robust, transparent and defensible capital investment plan across all service areas by linking level of service targets, asset performance and risk assessment
- Participate actively in the natural asset projects, green infrastructure initiatives, climate change adaptation/mitigation and energy management plans
- Draft terms of reference for the development of studies, reports, analysis, policies, and guidelines which may involve hiring of consultants, technical professionals or other external resources as required in delivering identified project outcomes within scope, schedule and budget
- Facilitate and consult with operational units, other divisions and departments, as well as the general public, as necessary, to ensure appropriate representation and to build consensus for the strategies, technical solutions and decision-support tools developed by the CAM Program

- Continue to implement the CAM Governance Model by coordinating Steering Committee and Network Team meetings
- Prepare and lead presentations on asset management initiatives to internal and external stakeholder groups, management and council
- Develop and prepare a variety of written documents, including technical reports, staff reports, work plans, business cases, terms of reference and newsletters
- Build and maintain positive working relationships with co-workers, other Town staff and the public using principles of good customer service
- Provide support to the departmental capital budgeting process
- Other related duties as assigned

You possess:

- Bachelor Degree in Business Administration, or Engineering, or Finance/Accounting, or equivalent
- Minimum of three years progressive experience in municipal government preferably in finance, engineering, planning, project management, or analytical studies in accounting
- Diploma/certificate or equivalent training in Asset Management or other relevant designation preferred
- Experience related to industry best practices, asset management business principles, lifecycle
 costing, level of service framework, risk assessment, infrastructure renewal costing and priority
 setting
- Experience with establishing capital and operating budget requirements
- Understanding of the lifecycle and function of municipal linear and vertical infrastructure
- Ability to oversee the management of consultants, development of terms of reference or requests for proposals, interpretation of reports and studies
- Ability to develop and maintain infrastructure inventory databases, infrastructure condition assessments
- Knowledge of condition assessment, inspection, rehabilitation and reconstruction techniques for linear and vertical infrastructure networks (such as transportation, stormwater management, fleet, parks and open spaces and facilities)
- Knowledge of and relevant working experience with computerized maintenance/work order management systems, Geographic Information Systems and database application development
- Excellent interpersonal skills, with the ability communicate, coordinate and collaborate with a range of stakeholders on a variety of issues
- Demonstrated skills working with multi-disciplinary teams
- Strong attention to detail and the ability to analyze data, identify trends and develop recommendations
